Questions were taken and additional points mentioned were:

- In his experience personalities can affect teams, we all need to work together
- The written constitution can be changed
- We need to listen to all concerns, but consider the place of the topic within our remit
- Consider which topics will 'go the distance', we may not be able to address all concerns
- It is an opportunity to look at other initiatives on the 'back of the plan'
- Evidence and publicity and communication to all community is important
- We need detailed record keeping an audit trail is required.
- Local council have a duty to provide information we seek
- Councils need evidence for their decisions
- If we have a contrary position to the council we need evidence ++
- We need to keep effective dialogues with local council
- The life of the plan will be 10 15 years
- We need to consult with other groups

- Developers should contribute to infrastructure and facilities
- We need protocols for communication
- We need to allow contributions from everyone involved
- Referendums need > 50% of people voting
- The Locality publication 'Neighbourhood Plans Roadmap Guide' downloaded from www.locality.org.uk was a useful starting point in producing a plan
